To the fullest extent permitted by law, I hereby waive any rights I may have to sue the event organizers (organizing authority, race committee, protest committee, LCYC including its officers, directors, members, volunteers, sponsors, or any other organization or official) involved with LCYC sailing events, with respect to property damage, or personal injury, including death, suffered by myself or my crew as a result of our participation in LCYC sailing events and hereby release the event organizers from any liability for such damage, injury, or death. The LCYC reserves the right, in its sole discretion, to revise the foregoing without advance notice and to refuse participation or entry to any person and/or boat. Each participant agrees that all crew shall be advised of the terms of participation and agrees to obtain permission of each responsible parent or guardian before any unaccompanied children or minor can participate.
